## Financial Obligation Agreement

**Plan 1: Payment in Full on or before registration**

**Plan 2: A down payment of 1/3 of your total charge, with the remaining balance paid over. Any balance remaining on your account on after January 11 for Spring 2021 will begin to accrue finance charge \$50 per each month.**

I understand that, should default occur on my student account, the whole sum shall become due at the option of IRUS.
